ORDER

Whereas your firm submitted its offer in the form of sealed quotation in respect of equipments in response to enquiry issued vide no. **SMVDU/S&P/SBT/UGC-SAP-DRS/2012/1132 dated 18/06/2012** and extension issued vide ref no. **SMVDU/S&P/SBT/UGC-SAP-DRS/2012/1777 dated 18/07/2012** for supply and installation of electrophoresis Unit for the School of Biotechnology, SMVD University;

Whereas after due scrutinization of quotation, your firm was found to be lowest by the School Purchase committee and , order for supply and installation of Electrophoresis Units with Power Supply was issued in favour of your firm vide order no. **19/SMVDU/S&P/UGC-SAP/2012/2901-03 dated 26.10.2012** to deliver the item within four weeks from the date of issuance of the Purchase Order;



Whereas in response to the above order, your firm supplied the electrophoresis Unit with faulty Power supply required for Electrophoresis Units and you were requested again and again via emails to replace the faulty power supply. After numerous reminders your firm replaced the Power supply but out of two replacements, one was again found faulty;

Whereas the matter was once again brought to the notice of your firm but, instead of supplying the faulty power supply, your firm neither replied nor supplied the item against letter issued vide letter no. **19/SMVDU/S&P/UGC-SAP/DRS/12/2015/161-163 dated 01.05.2015**;

Whereas in view of failure to supply the ordered material (Power Supply) at SMVDU, a show cause letter was issued vide ref no. 19/SMVDU/S&P/SBT/UGC-SAP/2015/1832-1835 dated 6.10.2015 to explain the reason for not supplying power supply for electrophoresis unit despite of several reminders;

Whereas in response to the aforementioned letter, your firm submitted its reply vide letter no. MB/161/2014 dated 16.10.2015 which is neither satisfactory nor has the faulty equipment being replaced;

Consequent upon above your firm i.e. **M/s Medox Biotech India Pvt. Ltd., 53/A (New # 24), 48th Street 9th Avenue , Ashok Nagar, Chennai-600083** is hereby **Blacklisted** for all future dealing with the University with immediate effect.
