- 3. The delivery period of equipment /material / items should be clearly mentioned in the quotation.
- 4. Please submit your quotation in sealed cover superscribing the Quotation Enquiry number and due date failing which the quotation is liable to be rejected.
- 5. Price quoted for the material / equipment shall be final and valid for 3 months.
- 6. Quotation without the authorization from the Company will not be accepted.

- 7. Delivery of material /equipment / stores mentioned in this quotation will be supplied by the supplier at SMVDU Stores at Kakryal, Katra-182320 (J&K).
- 8. Rate offered must be for metric system of unit lengths or volume or weight.
- **9.** SMVDU reserves the right to increase the quantity mentioned in this enquiry and SMVDU reserves the right to split this quotation and place order on one or more suppliers/ quotationers and the right to reject partly or completely quotations without assigning any reasons thereof.
- 10. The quotation shall be completed in all respects and the firms shall give the Make/ Brand name offered for the items in the quotations. Wherever applicable, technical literature may please be enclosed along with quotation.
- 11. The payment will be released after the receipt of all and complete material/equipment with complete accessories in good working condition.
- 12. Material/ equipment shall be guaranteed for the minimum period two years for satisfactory performance, workmanship and for the quality of material/ equipment supplied by the firm from the date of delivery/ installation.
- 13. Quotation received after DUE DATE will not be considered. SMVDU shall not be responsible for delays in postal transit.
- 14. All taxes / duties should be clearly mentioned in the Quotation.
