## **OFFICE ORDER**

<u>Sub</u>: "<u>Grant of permission (on ex-post facto basis) for attending 1<sup>st</sup> International Analytics Virtual Conference 2023 organized by Technology Innovation Hub, IIT Patna via Virtual Mode on dated: 11<sup>th</sup> February 2023 with financial assistance from PDA".</u>

With reference to an application submitted by Dr. Amit Kumar Sinha, Assistant Professor, School of Mechanical Engineering forwarded by Head, SoME & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

- a. Grant of permission in his favour for attending 1<sup>st</sup> International Analytics Virtual Conference 2023 being organized by Technology Innovation Hub, IIT Patna for presentation of his research paper entitled: 'Development in Additive Manufacturing through Enablers of IoT in Industry 4.0 Domain' via Virtual Mode on dated: 11<sup>th</sup> February 2023.
- b.
