Random surprise inspection would be carried out to verify facilities and if the institute is found deficient in fulfillment of norms & standards of AICTE, appropriate action would be initiated by the Council.

Please note that other terms & conditions in the earlier letter of extension of approval will remain unchanged.

This approval is granted based on the Appraisal of the Appraisal of the information by the institution of infrastructural facility and academic facilities created for the proposed course (s). Therefore the approval is subject to the verification of the claims made by the institution through an Expert Committee visit. In case the claims made by institution are found to be false, the approval granted shall be liable to be withdrawn.
