Subject: Appointment of CI & Co-CIs for Architectural and Structural Consultancy for the work of construction of tall monumental High Mast National Flag at SMVDU Complex.

With reference to the proposal from Ar. Aditya Kr. Singh, Associate Professor & Head, SoALD; letter issued vide No.SMVDU/R&D/22/1315, dated 01.07.2022 and as approved by the Competent Authority; sanction is hereby accorded to execute Architectural and Structural Consultancy for the work of construction of tall (45 mtrs.) monumental High Mast National Flag at SMVDU Complex.

Ar. Aditya Kr. Singh, Assoc. Professor, & Head, SoALD is hereby appointed as Consultant In-charge (CI) and other team members comprising of Dr. V. K. Dogra (Assoc. Prof), Ar. Abhiney Gupta (Asstt. Prof.), Ar. Navin Gupta (Asstt. Prof.), Ar. Abhimanyu Sharma (Asstt. Prof.) & Ar. Vishal Bhatti (STA), SoALD as Co-consultant Incharge (Co-CIs) for the said consultancy. The said consultancy shall henceforth be referred as 'CP/22/66'.

The estimated cost of the consultancy project excluding consultancy fee/ contingency is Rs.25,54,218/-(Rupees Twenty five lakh Fifty four thousand Two hundred Eighteen only). The Consultancy fee is 1.75% of the project cost excluding GST. The University share will be 25% of 1.75% i.e. 0.4375%. However, the consultancy fee paid to the individual consultant shall be liable for deduction of TDS at source, as per rules. The breakup of the consultancy charges is as under:-
