With respect to subject and reference as cited above, sanction is hereby accorded for the implementation of the Research Project entitled, "To study the genetic patterns among different cancers in Jammu & Kashmir Population India" sponsored by JK Science Technology & Innovation Council, Deptt. of Science & Technology, Govt. of Jammu & Kashmir for a duration of 02 years (from the date of commencement of the Project, i.e. the date of sanction letter issued by JKST&IC).
