Consequent upon the minutes of 32nd meeting of Executive Council of the University held on 21.02.2021 notified vide no. SMVDU/EC Affairs/21/147 dated 07.05.2021 and as approved by the Competent Authority; sanction is hereby accorded for change in the Doctor of Philosophy (Ph.D.) Ordinances, of SMVD University as enumerated in the Agenda Item no. 32.3.1.5 and as tabulated below;

A. After the successfuldefence of Pre-Ph.D.Synopsis of Ph.D. student, Supervisor of the Ph.D. student shall propose the Board of Examiners duly recommended by the SRC, for the evaluation of thesis of Ph.D. student. TheBoard will consist of the Ph.D.Supervisor(s) as Internal Examiner(s) and three External Examiners of which at least one will be from India and atleast one from abroad. As far as possible, must ensure that the proposed Examiners (Foreign/ Indian) for evaluation of Ph.D. thesisshould belong to Universities/Institutes having been ranked in the The Times Higher Education World University Rankings' for ForeignUniversities and among top150 NIRF ranking for Indian Universities/ Institutions. Each of the examiners shall be expert in the subject of the thesis. These external examiners may be chosen by the Vice Chancellor from a list of 10 examiners recommended by the supervisor(s) and approved bythe SRC after thoroughly checking the credentials of the proposed Examiners. The List of Examiners approved by the SRC, along with the synopsis, will be forwarded to the Vice Chancellor within two weeks from the date of approval of the examiners list and or four weeks from the approval of the synopsis.

A. After the successful defence of Pre-Ph.D. Synopsis of Ph.D. student, Supervisor of the Ph.D. student shall propose the Board of Examiners duly recommended by the SRC, for the evaluation of thesis of Ph.D. student. The Board will consist of the Ph.D. Supervisor(s) as Internal Examiner(s) and three External Examiners of which at least one will be from India and at least one from abroad. The panel of examiners for Ph.D. thesis evaluation recommended by School Research Committee (SRC) should not include, the name /names, of a person/persons, with whom the student has published her / his Research Paper / Papers. The supervisor shall obtain a list of publications including ones under view/communicated, from the student before submission of the proposal for panel of examiners. The supervisor shall also be required to give an undertaking to this effect (in the prescribed format) along with the list of Examiners. As far as possible, must ensure that the proposed Examiners (Foreign/ Indian) for evaluation of Ph.D. thesis should belong to Universities/ Institutes having been ranked in the The Times Higher Education World University Rankings' for Foreign Universities and among top 150 NIRF ranking for Indian Universities/ Institutions. Each of the examiners shall be expert in the subject of the thesis. These external examiners may be chosen by the Vice Chancellor from a list of 10 examiners recommended by the supervisor(s) and approved by the SRC after thoroughly checking the credentials of the proposed Examiners. The List of Examiners approved by the SRC, along with the synopsis, will be forwarded to the Vice Chancellor within two weeks from the date of approval of the examiners list and or four weeks from the approval of the synopsis.
