It is hereby notified for the information of all continuing students (UG/PG/Integrated) as well as those who have backlog(s), that they are required to complete the registration requirement in their respective Schools for **ODD Semester (Aug-Dec, 2022)** w.e.f 3<sup>rd</sup> August to 16<sup>th</sup> August, 2022.

Students who failed to pay their fees by 16<sup>th</sup> of August, 2022 shall be charged a late fee of Rs. 1000/- till 26<sup>th</sup> of August, 2022, which shall be the last date of registration with payment of late fee. **Name of those students who do not register by 26<sup>th</sup> Aug., 2022 will be struck off the rolls of the University.**

It may be noted that the Registration Form (for the Semester/s) will be done in Offline mode (format enclosed) to be submitted in hard copy & the payment can be made in Online mode/Offline mode. The Bank Account Details are mentioned below

In case a student is unable to deposit full tuition fee at the time of registration in odd semester (Academic Session 2022-23) due to unavoidable circumstances (only tuition fee can be partially paid). The concerned student shall be allowed for partial payment of tuition fee only in odd Semester (Academic Session 2022-23). However, he/she will have to pay a late fee of Rs.3000/- during registration for the Even semester (Jan-May, 2023).

Students must also ensure that before registering for the Odd Semester **they must clear all their pending dues (if any)**. It is also notified that the students will not be allowed to register in case they do not deposit the requisite fee and outstanding previous dues (if any) at the time of registration for academic courses. A copy of Registration form & fee payment proof is to be submitted in hardcopy in the office of the Head of the respective School for placement in the personal file of the concerned student.
