Sustainable economic growth is managing these resources in a manner that they will not be depleted and will remain available for future generations.

Through this conference, various issues concerning sustainable Economic growth and development shall be raised and it would hopefully arrive at a prudent and logical conclusion which policy makers could use as guiding principles at various levels of planning and decision making. One soft copy of the research paper in Microsoft Word will have to be submitted to the Conference Organizing Secretary by 23rd February, 2017. The electronic version of the paper should be e-mailed to: pabitra@smvdu.ac.in and acceptance of the paper imply that at least one of the authors will attend the conference and present the paper. Papers must include a clear indication of the purpose of the research, methodology, major results, implications and references. They should adhere to the following:

Maximum Length	6, 000 words including title/cover page and References.
Margins	One inch all sides
Font	Times New Roman, 12 points Justified
Line spacing	1.5
Title Page	Title, author(s), affiliation(s), contact details, Email address
Extended Abstract of full paper	Not more than 500 words and a maximum of five key words
Table. Diagrams etc.	Tables, illustrations, charts, figures, formulae etc. should be placed within the text at appropriate places.
References	It should be in the Harvard Referencing Style

Paper without soft copy will not be entertained. The authors must send a declaration that the paper is original and has not been sent/submitted elsewhere for publication or presentation in any conference/seminar/journal and will not be considered for the same up to the end of this conference.
