Sub: Blacklisting from University Business

Ref: 1) Tender no. SMVDU/S&P/SoBT/BIF/PR-15/2019-20/208 Dated: 17th July 2019.

2) Letter issued vide No: SMVDU/S&P/2021/766-72 Dated: 29th October 2021, which stands withdrawn.

Whereas in response to the tender notification issued vide Tender no. SMVDU/S&P/SoBT/BIF/PR-15/ 2019-20/208 dated 17th July 2019 for the Supply and Installation of HPC Server for BIF Lab at SMVDU, your firm "M/s Amtrak Technologies" had submitted the tender on 21st August 2019 (at PRO) and 22nd August 2019 (at SMVDU campus).

Whereas, the technical bids of the tenders were opened by our Central Level Purchase Committee (CLPC) on 22nd August, 2019 and the financial bids of the same were opened on 8th November, 2019 respectively.

Whereas, SMVDU had received an email dated 26th November 2019 from M/s Dell International Services India Pvt. Ltd. wherein the Principal Company informed that they have authorized only 03 partners, namely M/s Softel Solutions Pvt Ltd, M/s Aman Technologies and M/s Itek Logics Pvt Ltd to submit a bid for the tender. But they had not authorized M/s Amtrak Technologies, Jammu to submit the bid for the above tender.

Whereas, the MAF/authorization certificate dated: 19th August, 2019 submitted by your firm was forwarded to the M/s Dell International Services India Pvt. Ltd. on 28th November, 2019 to verify the same and the Principal Company has confirmed that they have not issued the attached MAF / authorization certificate to M/s Amtrak Technologies, Jammu.

Whereas, an email was sent to you vide email dated: 6th December, 2019 to clarify on the above matter and replied furnished by your firm was examined and found to be not-satisfactory.

Whereas, the matter was placed before the CLPC, the CLPC had recommended to the Competent Authority, for the following:

- 1) Disqualification of M/s Amtrak Technologies from tendering Process
- 2) Forfeiture of EMD
- 3) Blacklisting of the firm

Whereas, Show Cause Notice was issued vide No: SMVDU/S&P/20/142-144 Dated 26th November, 2020 to your firm as to why the action w.r.t. disqualification of the firm from the tendering/process & blacklisting be not initiated in lieu of furnishing misleading & false information to SMVD University .



Whereas, in response to the above, your firm submitted its reply to the Show cause dated 7th December, 2020 and the same was placed before the CLPC meeting held on 8th March, 2021 and the reply of your firm was again not found satisfactory.

Whereas, your reply dated 7th December, 2020 was also forwarded to the Principal Company i.e. M/s Dell International Services Private Limited, Bangalore and the Principal Company has confirmed that as under:

“We would like to clear here that as per the official process at Dell Technologies only Accounts Team i.e. the team dedicatedly assigned for Shri Mata Vaishno Devi University at Dell Technologies (Which includes me Robin Hora & my Inside Counter Part) are authorized to share a Tender specific MAF to the partner for Tender participation. As highlighted earlier also that none of us has shared a valid MAF to partner for Tender participation.”

Whereas, the Competent Authority has taken a very serious view on the matter w.r.t. misleading and furnishing the false information to SMVDU as a consequence of which your firm is being blacklisted for all future dealing with the University with immediate effect.

Also, the previously issued letter vide no: SMVDU/S&P/2021/766-72 Dated: 29th October 2021 for the above cited subject stands withdrawn.
