 - i) possess the highest level of competence, integrity, morals and institutional commitment.
 - ii) be a visionary with proven leadership qualities and reputed academician with proven administrative acumen and ability.
 - iii) has an outstanding academic record throughout and a minimum of 10 years' experience as a Professor in a Government University / IISc/IITs/IIITs/NITs and similar Institutions or 10 years' of experience in an equivalent position in a reputed research and / or academic administrative organization with proof of having demonstrated academic leadership.
 - iv) has a proven academic and administrative record.
- 4. The Vice Chancellor shall:
 - i. hold office for a minimum term of three years extendable up to five years from the date of entering office.
 - ii. be not more than 65 years of age as on closing date of receipt of applications of this advertisement.
- 5. Salary and Service Conditions:
 - i. The post carries a pay of Rs.2,10,000/- (Fixed) per month with other usual allowances as admissible or as determined by the Chancellor of the University.
- ii. The terms and conditions of the appointment shall be as prescribed in the Act, Statutes and Regulations of the University.
