### NOTIFICATION

**Sub: Summer Semester Registration for Academic Session 2022-23 as per Academic rules & Regulation**

It is hereby notified for the information of all concerned that Summer Semester for the Academic Session 2022-23 shall commence from 22<sup>nd</sup> May, 2023.

The following shall be the guidelines governing the Summer Semester for Academic Session 2022-23.

- Students can register for a maximum of 12 credits during the Summer Semester. These courses can belong to Even or Odd Semester. The Minor & Major Exams are conducted during the course of the Summer Semester as per the Schedule.
- Registration in Summer Semester is only open to those students who are on the verge of passing out the program and are deficient in total credit requirements up to 12 credits for award of degree. Such students may be allowed to register up-to 12 credits for the backlog courses or other eligible courses in lieu thereof or for improvement in grade of a course, if so eligible.
- The backlog courses can be registered in which the student has met the minimum attendance criteria earlier.
- The registered courses can be taken on Self-study basis where attendance requirement shall not be applicable in the summer semester.
- The registered student will be required to submit all the assignments and appear in the Minor & Major Exam and complete all other course related requirements as communicated by the course coordinator.
- Registration in Major Project, Dissertation and Project/Thesis is not allowed in the Summer Semester.
- B. Architecture Students, registration in the core studio based courses (Architecture Design, Building Materials & Construction) & Thesis/Dissertation is not allowed in the summer semester.
- Students who wish to register for Summer Semester are required to submit their choices regarding the courses that they may like to register for, during the Summer Semester in the prescribed application form (as annexed) latest by 10<sup>th</sup> May, 2023 to their Head of School.
- Considering the requests of the students, the final list of courses being offered for registration will be forwarded to Examination Section on 11<sup>th</sup> May, 2023.
- Registration for the Summer Semester will be done on 16-18<sup>th</sup> May, 2023. Students are required to ensure submission of relevant Academic Fee and Mess Fee for the Summer Semester at the time of registration on 16-18 May, 2023
- Registration fee for Summer Semester shall be Rs. 3000/- per course & Mess fee as per actuals (on per day basis) will also be charged, however no additional hostel fee needs to be paid.
