Sub: "Grant of permission to attend 2nd International Conference on Electrical, Computer, Communications and Mechatronics Engineering (ICECCME 2022) at The Maldives National University, Maldives w.e.f. 16th – 18th November 2022 with financial assistance from PDA".

With reference to the application submitted by Dr. Sachin Kumar Gupta, Assistant Professor, School of Electronics & Communication Engineering, forwarded by Head, SoECE & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Sanction is hereby accorded in his favour for the following:

- Grant of permission in his favour to attend '2nd International Conference on Electrical, Computer, Communications and Mechatronics Engineering (ICECCME 2022)' being organized by The Maldives National University, Maldives, IEEE & University of Mauritius w.e.f. 16th 18th November 2022 at The Maldives National University, Maldives for oral or video presentation of his research paper entitled: 'Intelligent Collaboration of Multi Agent Flying UAV-Fog Networking for better QoS' with financial assistance out of his PDA from the block period of 03 years i.e 2020-23 and FY 2021-22 & 22-23, as per University rules.

He shall also present a seminar on the same topic in his School for the benefit of all Faculty members & Students.

Further, he must submit the re-imbursement request by or before the 20th of March of the current financial year, otherwise, the order issued w.r.t. financial assistance under PDA be considered as null and void and no financial assistance shall be provided to him.
