Sub: "Grant of permission to attend 2nd International Conference on Electrical, Computer, Communications and Mechatronics Engineering (ICECCME 2022) at The Maldives National University, Maldives

w.e.f. 16th – 18th November 2022 with financial assistance from PDA".

With reference to the application submitted by Dr. Vijay Kumar Sharma, Assistant Professor, School of Electronics & Communication Engineering, forwarded by Head, SoECE & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Sanction is hereby accorded in his favour for the following:

- a) Grant of permission in his favour to attend '2nd International Conference on Electrical, Computer, Communications and Mechatronics Engineering (ICECCME 2022)' being organized by The Maldives National University, Maldives, IEEE & University of Mauritius w.e.f. 16th 18th November 2022 at The Maldives National University, Maldives for oral or video presentation of his research paper entitled: 'Structure for Demultiplexer in QCA Technology for Nanocommunication Systems' with financial assistance out of his PDA from the block period of 03 years i.e 2020-23 and FY 2021-22 & 22-23, as per University rules.

Dr. Vijay Kumar Sharma shall however, separately apply for the kind of leave as may be due to him providing therein the leave arrangement of his teaching load & other assignments to the Dean (AA) through Head of the School for the period of his absence, before proceeding for attending the above said Conference.

Dr. Vijay Kumar Sharma shall also submit his participation certificate and a report of attending the aforesaid Conference to this office after resuming his duties at this University, along with his joining report. He shall also present a seminar on the same topic in his School for the benefit of all Faculty members & Students.

Further, he must submit the re-imbursement request by or before the 20th of March of the current financial year, otherwise, the order issued w.r.t. financial assistance under PDA be considered as null and void and no financial assistance shall be provided to him.
