Students, who register after 3rd April, 2023 shall be charged an amount of Rs. 1000/- till 15th April, 2023; which will be the extended last date of registration. Those Students who fail to register by 15th April, 2023, their name will be struck off from the rolls of the University. **The hard copy of the Registration Form, duly signed shall be submitted to the concerned Head of School for records.**

The students are required to pay all pending dues at the time of Registration, (if any). Students whose partially tuition fee is pending for Academic Session 2022-23 (Aug-Dec., 2022) shall have to pay a fine of Rs. 3000/- along with the amount of pending tuition fee.

The Heads of school will maintain a record of all the students who have registered and have submitted the hard copy of the Registration Form & the list of students who have not completed the registration form. Further, the Heads of schools shall send due reminders to the students of their School who have not completed the registration process.

The list of registered students (program wise, class wise, course wise) shall be sent by the Heads of the school to the Academic Affairs Wing for records and to all other relevant Schools for information.
