<u>Sub</u>: "<u>Grant of permission (on ex-post facto basis) for attending National Conference on Advanced</u>

<u>Materials and Manufacturing Technologies (AMMT 2023) w.e.f. $23^{rd} - 24^{th}$ February 2023 at CSIR-NIIST, Thiruvananthapuram with financial assistance from PDA".</u>

With reference to an application submitted by Dr. Ram Prakash, Assistant Professor, School of Physics forwarded by Head, SoP & Dean I/c, FoS and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

- a. Grant of permission in his favour for attending National Conference on Advanced Materials and Manufacturing Technologies (AMMT 2023) for poster presentation of abstract of his research paper entitled: 'Structural, Optical and Spectroscopic analysis of Dy doped ZrO ' at CSIR NIIST, Thiruvananthapuram w.e.f. 23rd 24th February, 2023.
- b. Further, he must submit the re-imbursement request by or before the 20th of March of the current financial year, otherwise, the order issued w.r.t. financial assistance under PDA be considered as null and void and no financial assistance shall be provided to him.
