The Executive Committee of Council of Architecture (COA) at its 103<sup>rd</sup> meeting held on 27<sup>th</sup> January, 2010 has decided, inter alia that the Council will inspect an institution from where atleast one batch is yet to pass out after an interval of 3 years.

2. Further, the Executive Committee also decided that every architectural institution is required to submit information in form-B & C every year. Further, an Institution is also required to submit information in the prescribed proforma being sent separately, for displaying the same on the CoA website & any such other medium that the Council may deem fit from time to time.

3. Please note that if any information supplied by the institution is found to be at variance with the actual situation on ground, the council reserves the right to withdraw the above permission sanctioned intake irrespective of the period of approval and/or take such other action against the institution as the Council may deem fit.

4. Your institution was last inspected on 30<sup>th</sup> & 31<sup>st</sup> March 2009, for extension of approval to the existing B.Arch. degree course. The Forms B & C for the current academic session have been received. On the basis of the same, I am directed to state that the Executive Committee is pleased to accord **recognition/extension of approval** to your institution as details given below:
