## OFFICE ORDER

Sub: "Grant of permission (on ex-post facto basis) for attending International Conference on Sustainable Design and Eco Technologies for Infrastructure w.e.f. 21st - 23rd Sept., 2022 at Panaji,

Goa, India with financial assistance from PDA"

With reference to an application submitted by Dr. Rahul Sharma, Assistant Professor, School of Civil Engineering forwarded by Head, SoCE & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

- 1.
