With reference to an application submitted by Dr.Vaibhav Rajiv Sapkal, Assistant Professor, School of Civil Engineering forwarded by Head, SoCE & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

1.
