## OFFICE ORDER

Sub: "Grant of permission to attend Microwave, Antennas and Propagation Conference (MAPCON) at The Leela Bhartiya City, Bangalore, India w.e.f. 12<sup>th</sup> – 15<sup>th</sup> December, 2022 with financial assistance from PDA".

With reference to an application submitted by Dr. Kumud Ranjan Jha, Associate Professor, School of Electronics & Communication Engineering duly forwarded by Head, SoECE & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, sanction is hereby accorded in his favour for the following:

- 1. Grant of permission to attend 'Microwave, Antennas and Propagation Conference (MAPCON) being organised by IEEE MTT-S and IEEE AP-S for presentation of his 02 no. of research papers entitled: '3-D Triple Band and Wideband Antenna for V2X Communications' and 'Active Wideband Polarization Insensitive Absorber for Ku and K-Band' at The Leela Bhartiya City, Bangalore, India w.e.f. 12<sup>th</sup> 15<sup>th</sup> December, 2022 with financial assistance out of his PDA from the block period of 03 years i.e 2020-23 and FY 2021-22 & 22-23, as per University rules.

Dr. Kumud Ranjan Jha shall submit his participation certificate and a brief report of attending the aforesaid Conference to this office for records. He shall also present a seminar on the paper presented in his School for the benefit of all Faculty members, Scholars & Students.

Further, he must submit the re-imbursement request by or before the 20<sup>th</sup> of March of the current financial year, otherwise, the order issued w.r.t. financial assistance under PDA be considered as null and void and no financial assistance shall be provided to him.
