CIRCULAR

Sub: Vehicles Hire Charges.

It has been observed that in view of non-availability of University Vehicles for Official work(s), the concerned Deans/ Heads/ Section Heads/ PIs/ CIs/ PDs/ Coordinators of respective projects, workshops, seminars, conferences and FDP's etc are required to hire vehicles from the local market from time to time.

With a view to regulate such expenses within the prescribed limits, it is enjoin upon all the concerned to follow the notified chargeable passenger fares in respect of Big Buses, Medium Mini Buses and Taxi/ Maxi Cab (Daily Rate for 11 hour) and Taxi- Maxi Cabs (per km rate) for passenger vehicles, as notified by the Transport Commissioner and Chairman State Transport Authority, J&K vide Notification No. 01 P-MVD of 2021 dated 19.03.2021 issued under endorsement no. TC/JK/P&S/73-V/P-668-757 dated 19.03.2021 and as amended from time to time.

The relevant Annexures "C-I" and "C-Ia(1)" are enclosed herewith for ready reference.
