Sub: "Grant of permission (on ex-post facto basis) for attending Silver Jubilee (Annual)

With reference to an application submitted by Dr. Sandeep Bhougal, Assistant Professor, School of Mathematics forwarded by Dean I/c, FoS & Head I/c, SoM and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, ex-post facto sanction is hereby accorded in his favour for the following:

- a. Further, he must submit the re-imbursement request by or before the 27<sup>th</sup> of March of the current financial year, otherwise, the order issued w.r.t. financial assistance under PDA be considered as null and void and no financial assistance shall be provided to him.
