The Hon'ble Vice Chancellor further informed that due to paucity of time, the emergency meeting of the Academic Council had to be called to discuss and deliberate upon a few Academic issues of vital importance which needed to be examined and recommended by the Academic Council before the same are put up to the Executive Council in its meeting scheduled on 21/03/2014.

### Agenda Re-structuring of Council of Students Affairs (CSA) Item No.21.3

The proposal for Re-structuring of Council of Students Affairs (CSA) and renaming it as Student Affairs Council (SAC) was deliberated at length by the Academic Council. The Vice Chancelle apprised the house the necessity for re-structuring of CSA, so that the students residing on the Campus are continuously engaged in the varied creative, cultural and sports activities and to ensure participation of the entire cross-section of students in these activities rather than participation by only a limited number of them. The I/c Dean of Students explained the need for the creation of Boards within the CSA (to be renamed as SAC) for managing various students affairs and providing them opportunity to discuss and formulate the Policies and organizing the students related activities and enable them to become more responsible citizens. It was clarified that the NSS activities would be included in Board for Student Welfare (BSW).

The Academic Council accorded in principle approval to the proposal for Re-structuring of Council of Students Affairs and renaming it as Students Affairs Council (SAC). The Academic Council also approved the Constitution of the Students Affairs Council (SAC) and its Constituent Boards.

The matter is placed before the Executive Council for consideration and approval.

#### Agenda Item No.21.17

#### Introduction of Post-Doctoral Fellowship

The Academic Council considered and accorded in principle approval to the proposal fo Introduction of Post-Doctoral Fellowship in various Schools of study in the University with the objective of enhancing the research activities and the resources in the Schools. Post-Doctoral Fellows in the Schools will significantly enhance the research output and provide platform for furthering the research capacity of the Schools. This will also provide additional teaching backup in the Schools.

The professional area of Post-Doctoral Fellow shall pertain to the areas of research/teaching in various Schools of the University.

#### Eligibility:

Candidates should possess a Ph.D. degree (awarded) in respective academic discipline and should meet the eligibility condition for a faculty position in SMVDU in the concerned School

#### Amount and Duration of Fellowship:

The Fellow will be entitled to fellowship amount of Rs. 30,000/- per month for a period of 12 months extendable by another six months twice, subject to satisfactory performance in terms of research output/publications A Post-Doctoral Fellow will also be entitled to a contingency grant/Professional Development Allowance (PDA) upto a maximum of Rs. 40,000 per annum.

The proposal as approved by the Academic Council is placed before the Executive Council for consideration and approval.



Agenda Item No.21.18 Introduction of Scheme for improvement in Grade(s) obtained by students in various Courses

The Academic Council considered the proposal for Introduction of Scheme for improvement in Grade(s) obtained by students in various Courses and appreciated the proposal as it would provide an opportunity to the students to improve upon their Grades during the regular or summer semester. It was however resolved to replace the word "re-credit" with "re-register" in the proposal.

The Academic Council recommended the proposal (for Introduction of Scheme for improvement in Grade(s) obtained by students in various Courses) to the Executive Council for consideration and approval.

## Agenda Any other item with the permission of the Chair Item No.21.19

1. Dr. V.K.Tripathi, Director I/c SOPC pointed out that the Research Assistantship as applicable to the research scholars who get admission in Ph.D. programme due to their being NET qualified should also be available in favour of such of those Ph.D. research scholars who subsequently during their pursuing Ph.D. at SMVDU qualify NET for fellowship.

The Academic Council endorsed the view and it was decided that such of the Ph.D. research scholars who at the time of their admission at SMVDU were not NET qualified but qualified UGC-NET later on should also be eligible for Assistantship as available to Ph.D. scholars who are UGC-NET qualified. However, this provision shall be effective only after the date the proposal of Assistantship gets approved by the Executive Council and implemented at SMVDU.

The Academic Council while recommending the same desired that the same be put up to the Executive Council for consideration and approval.

The meeting ended with a vote of thanks to the Chair.
