Notification

Sub: Issuance of Degree Certificate to passout students.

In supersession to previous notifications on the subject matter, the following procedure is hereby re-notified for issuance of degree certificates to the passout students of this University who were unable to attend the Convocation.

- 1) For collecting the degree in person, the student is required to visit the University on any working day and submit an application in this regard to his/her Head of School enclosing herewith a copy of his/her ID proof. The student shall have to deposit degree fee of Rs.1000/- in the University Bank account at J&K Bank Ltd. SMVDU Campus Branch. The application shall be routed to the examination wing through Head of the concerned School with remarks (if any). The examination wing shall process the application of student after verifying all the relevant details of the student.
- 2) In case the student is unable to come to the University for receiving the degree in person, he/she can submit an application in the prescribed format(as enclosed) for sending his/her degree by post on the address confirmed by the student in his/her application. The scanned application form(duly filled) in the prescribed format along with the requisite enclosures shall be sent by email to concerned Head of School on his/her official email ID for recommending the same to Examination wing for further processing.
- 3) In case the student is unable to visit the University for collecting the degree in person, he/she may authorize their parent for collecting the same on their behalf. In this case, the authorization shall have to be given by the student in the shape of an affidavit on a non-judicial stamp paper in the enclosed format to be submitted by the concerned parent alongwith ID proof and payment of Rs.1000/- as fee for the purpose. The application in this respect alongwith the affidavit shall be submitted to the Head of the concerned School and shall be forwarded to the examination wing with due recommendations.
