capping the time period for payment of Annual Fee

The Academic Council had detailed deliberations on this issue and the Council was of the view that research is a very important aspect of the University system and this is done traditionally by encouraging students to pursue research by paying them Assistantship. The Academic Council was of the view that high fee being charged from Ph.D. students (approx. Rs. 1.40 lacs per annum including Mess fee) will act as a detriment to attracting talented and quality students and the university must look at avenues to reduce the fee while simultaneously looking at options by which students could be paid some remuneration for assisting in academic activities. The Academic Council recommended that the Annual Fee for Ph.D. Programs may be reduced from Rs.70, 000 /- to Rs.35, 000/-.

The matter shall be placed before the Executive Council through Finance Committee.

Resolution

The Academic Council observed that the 5th batch of students will be admitted to the 5 Year Integrated M.Sc. (Economics) program in the forthcoming session and the program appears to have matured with the introduction of senior and quality faculty. It was thus recommended that from Session 2018-19, the admission to the program must be based on Entrance Test (Written Test) to ensure that only quality students are admitted to the program.

Resolution

The Academic Council noted the introduction of option of Specialization of Genetics in the M.Sc. (Biotechnology) program and the consequent enhancement of intake of M.Sc. (Biotechnology) from 30 to 40 seats.

It was further decided that the students who qualify the 1st Year of M.Sc. (Biotechnology) program with no backlogs, shall be eligible for opting Genetics Specialization before commencement of 2nd Year. The students who wish to pursue this specialization shall be required to submit their choice in writing to the HoD, SoBT. In case the number of such students is more than 10, the merit list shall be decided based on the CGPA of the students (No Backlogs) at end of 1st Year (after Summer Semester).

Resolution

The Academic Council noted that an undertaking has been obtained from the students joining the Ph.D. Program in the Schools under Faculty of Engineering & Faculty of Science, from Academic session 2018-19 (Dec-May 2018 Semester), confirming that he/she would file a patent, besides meeting other laid out requirements, to be eligible for award of Ph.D. degree.

A similar undertaking has also been obtained from the students joining the Ph.D. Program in the Schools under Faculty of Management & Faculty of Humanities & Social Science, from Academic session 2018-19 (Dec-May 2018 Semester), confirming that he/she would file a copyright based on Ph.D. Work/provide acceptance of the case study based on Ph.D. Work from approved institutions, besides meeting other laid out requirements, to be eligible for award of Ph.D. degree.

The Academic Council commended the efforts being made to improve the quality of research being done by the Ph.D. students which will go a long way in improving the research profile of the University.

In view of introduction of Engineering Entrance Test of the University SMVDUEE-2018, for admission to B.Tech. program, the Academic Council also approved the revision of the eligibility criteria for admission to the B.Tech./B.Arch. program, based on the admission process:

For B.Tech.

- Candidate applying for admission to B. Tech. program through JOSAA/CSAB 2018 must satisfy the eligibility criteria as per JOSAA/CSAB 2018 guidelines.
- iii. Candidates applying for admission to B.Tech. program through SMVDU Direct Counseling (Subject to availability of vacant seats) based on JEE(Main) 2018 Rank (CRL) must satisfy the eligibility criteria as per JOSAA/CSAB 2018 guidelines except that the minimum aggregate percentage obtained at 10+2 must be 60% or equivalent GPA.
- Candidates applying for admission through Shri Mata Vaishno
 Devi University Engineering Entrance 2018 (SMVDUEE-2018)
 must satisfy the following eligibility criteria:
 - Only those candidates whose date of birth falls on or after October 01, 1993 are eligible. However, in the case of Persons with Disabilities (PwD) candidates, upper age limit is relaxed by 5 years, candidates who are born on or after October 01, 1988 are eligible. Date of birth as recorded in the Secondary Education Board/University certificate will only be considered.
 - Only those candidates who have passed their Class 12th Exam or any equivalent qualifying examination in 2016 or 2017; or those who are appearing in their Class 12th Exam or any equivalent qualifying examination in 2018 are eligible to appear in SMVDUEE(Main)- 2018. Candidates who passed Class 12th/Qualifying examination in 2015 or before as well as those who will appear in such examination in 2019 or later are not eligible to appear in SMVDUEE 2018.

 Candidates must have taken at least five subjects in class 12th/qualifying examination in order to be eligible for writing SMVDUEE - 2018. The candidates who have taken four subjects are not permitted to write SMVDUEE-2018 and if such candidates appear in SMVDUEE-2018 by furnishing wrong information, their provisional admission will be cancelled at any stage. Candidates must have obtained a minimum of 60% aggregate marks in Class 12th /qualifying exam or equivalent GPA.

For B.Arch.

- Candidate applying for admission to B. Arch program should satisfy the eligibility criteria as per JOSAA/CSAB 2018 guidelines and Council of Architecture (CoA) guidelines.
- Candidates applying for admission to B.Arch. program through SMVDU Direct Counseling (Subject to availability of vacant seats) based on JEE(Main) 2018 Rank (CRL)-Paper-2 must satisfy the eligibility criteria as per JOSAA/CSAB 2018 guidelines except that the minimum aggregate percentage obtained at 10+2 must be 60% or equivalent GPA. Further, candidates having valid NATA 2018 Score will also be eligible for applying for admission to B.Arch. program through SMVDU Direct Counseling. However, preference will be given to candidates with valid JEE (Main) 2018 Rank (CRL)-Paper-2.
