During pre-inspection, if any bidder(s) fails to meet the compliance of the requested product configuration and additional terms and conditions of tender, then the bid of the respective bidder shall be stand rejected.

It is reiterated that no purchase of Desktop Computers shall be made unless the above standardized specifications are adhered to. These are valid for a period of two years from the date of issuance of the above notification.
