## **Detailed Notice**

- 1. Owing to overwhelming response received against Faculty recruitment notification no: SMVDU/Adm/Estt.-FA/Rect.Adv/1 of 2023/1252, dated: 14/09/2023, published in M/s. Daily Excelsior, M/s. Times of India [Ascent], M/s. Employment News and uploaded on the University Website, and subsequent 'Extension Notices' issued vide no: SMVDU/Adm/Estt.-FA/Rect.Adv/1 of 2023/1507, dated: 03/10/2023& SMVDU/Adm/Estt.-FA/Rect.Adv/1 of 2023/1721 dated: 27/10/2023 inviting applications for various faculty positions, all the applicants are hereby informed that the University is constrained to withdraw the Clause no. 5 (dealing with exemption from appearing in written test) & Clause no. 29 (dealing with reimbursement of train fare for all positions) of General Terms and Conditions of the faculty recruitment notice. The same has also been published in Daily Excelsior and Times of India (Ascent) vide no. SMVDU/Adm/Estt.-FA/Rect.Adv/1 of 2024/2554 dated: 23-01-2024. Accordingly, all the candidates who have been declared as provisionally eligible shall be required to appear in the written. *The syllabus of* GATE Examination shall be the syllabus for the written test for short listing of candidates for further stages of the recruitment process.
- 2. The candidates, who have not been found eligible after initial scrutiny for the post of Assistant Professor based on the documents submitted by them, may submit additional documents/ Certificates justifying their candidature. Candidates can do so by submitting documents indicating inter alia proof of discipline from the where the degree has been completed; transcript of the degree and/ or any other documentary evidence in support of their respective claims and same shall be required to be 6<sup>th</sup> submitted latest by February 2024 via email recruitment.electrical@smvdu.ac.in. Any claims received after the due date shall not be entertained and status of such candidates shall be treated as not eligible for rest of the selection process.
- 3. Candidates who have not submitted proof of class/ division at UG/ PG level at the time of submitting applications are required to submit the same by the due date as indicated herein below. Incase any candidate is unable to submit the same within the prescribed timeline, such cases shall be finalized as stipulated under clause 7.3 of AICTE regulations 2019.
- 4. Candidates who have obtained their Ph.D. from Universities/ Institutions not covered under the ambit of Institution of National Importance are required to submit Minimum Standards and Procedures (MSP) certificate for consideration of their Ph.D. degree for further recruitment process.
