The agenda points were discussed at length and resolved by BoS as follows:

- 1) In the course curriculum of IIIrd semester, B.Tech. Civil Engineering, CEL2061- Geotechnical Engineering - I (L-T-P 3-0-0, credits - 3) is one of the core subjects. During the current Academic Year 2020 - 21, this subject is to be taught, for which concerned faculty recruitment process is under consideration. The faculty in SoCE could not be recruited till date due to lockdown and current pandemic situation. Taking into consideration of current circumstances and non-availability of concerned faculty, it is decided to undertake this course by NPTEL. Soil Mechanics/ Geotechnical Engineering – I (12-week) course is offered by IIT Kharagpur on NPTEL for current session. The syllabus of CEL2061 - Geotechnical Engineering – I offered by SoCE and course offered by NPTEL is almost similar. The marks obtained (percentage) by the students in the NPTEL course, shall be converted into grades as per SMVDU grading system. Taking into consideration of current circumstances and non-availability of concerned faculty, it is approved by the house to undertake this course by NPTEL for only the current Academic Year. If the recruitment process of concerned faculty will be done in near future, this course will be taught by newly appointed faculty.
- 2) As per the recommendation of the model curriculum of AICTE, Mathematics III subject (optional) also is to be included in the second year (4th Semester) for B.Tech. Civil Engineering 2019 batch onwards, from the current academic year as an audit (Non-Credit) course (L-T-P 3-0-0). B.Tech. Civil Engineering 2018 batch students, who are now in the third year (5th semester) will complete this audit course in VIth semester during the current academic year (2020-21).


