Subject: Minutes Of 3rd Meeting of the Board Of Studies Of The School Of Computer Science & Engineering Held On 27.4.2011 in the Conference Room of the College of Engineering at 3.40 pm

Item No.1 Intake for M.Tech(CSE)

The school of CSE is schedule to start M.Tech(CSE) from the academic year 2011-2012. The case for AICTE approval is already in process. The maximum intake for M.Tech(CSE) shall be limited to 25. However it will not be mandatory to fill up all the seats with eligible candidates. The Seats shall be announced to be filled up through prospectus/Advertisements in newspaper/website of SMVDU every year as per the faculty & other resources available in the school. For the Academic Year 2011-12, the intake shall be limited to ten. The Board of Studies discussed the matter and decided to accept the item.

Item No.2 Pre-requisites for B.Tech subjects floated by the school of CSE

Some B.Tech subjects cover advanced topics whose fundamentals/preliminary knowledge is covered in the introductory subjects assumed to have been passed before taking up the advanced subjects. The introductory and advanced subjects may form a chain where in all the subjects appearing before a particular subject in the chain form its prerequisites. The pre-requisites for each subject prepared by the faculty of CSE as per annexure-'A' were considered by the BOS and decided to accept the same. The prerequisite may mean that the student should have attended the prerequisite subject.

Item No.3 Additions/Modifications of course outlines for some B.Tech subjects.

i. Software Engineering (ECSL 205B) (3-0-0)

Some new topics such as Agile process, Cohesion Coupling Model, Design Verification & Metrics, Black Box & White Box Testing, Alfa & Beta Testing etc in Software Engineering are proposed to be included in the already existing outlines of the subject. The updated course outline proposed as per Annexure 'B' was considered and recommended for acceptance by the Board of Studies of the School.

ii. Introduction to Data Structure with 'C'(ECSL 208B) (2-0-2)

This introductory course on Data Structure with 'C' is being run for B.Tech (ECE) and B.Tech(IBT) students. Although Lab is the integral part of the course structure but the experiments to be performed in the lab have not been defined. The course outline proposed to be modified by including the list of experiments to be performed by the Students as per Annexure' C' was considered and recommended for acceptance by the BOS.



iii. Introduction to Computers & Programming Lab(ECSP 110B)(0-0-2)

In the existing course outline for the lab, the course outline does not mention the experiments to be performed for the subject but instead mention the course outline for the subject. The course outline for the lab proposed as at Annexure 'D' was considered and recommended for acceptance by the BOS.

Item No. 4 Mercy Chance for B. Tech Students

Presently the regulations demand that the B.Tech students must clear the requirements for B.Tech degree in a maximum span of six years (12 semesters). But there could be some isolated cases like that of Mr.Nirantar Kumar who belongs to the 2005 Batch of B.Tech but has not yet passed some subjects to qualify for the award of B.Tech degree. He has submitted an application that he may be allowed to register for the subjects in the academic year 2011-12. The Board of Studies discussed the matter in detail and recommended that a mercy chance may be considered to be allowed by the Competent Authority. However the period (semesters) of withdrawal with permission from Competent Authority may not be counted towards the total period allowed for the completion of the course.
