
**Sub: Summer Semester Registration for Academic Session 2023-24 as per Academic rules & Regulation**

It is hereby notified for the information of all concerned that Summer Semester for the Academic Session 2023-24 shall commence from 27<sup>th</sup> May, 2024.

The following shall be the guidelines governing the Summer Semester for Academic Session 2023-24.

1. Students can register for a maximum of 12 credits (Backlog/Improvement courses) during the Summer Semester. These courses can belong to Even or Odd Semester. The Mid-semester & Major Exams will be conducted during the course of the Summer Semester as per the Schedule.
2. The summer semester will be open to all batches from the forthcoming semester and onwards .
3. If the number of registered students in a particular course is small, course may be offered in online mode, however mid-semester and major exams will be conducted in offline mode only.
4. The registered student will be required to submit all the assignments and appear in the Mid-semester & Major Exam and complete all other course related requirements as communicated by the course coordinator.
5. Registration in Major Project, Dissertation and Project/Thesis is not allowed in the Summer Semester.
6. Registration for B. Architecture Students in the core studio based courses (Architecture Design, Building Materials & Construction) & Thesis/Dissertation is not allowed in the summer semester.
7. Students who wish to register for Summer Semester are required to submit their choices regarding the courses that they may like to register for, during the Summer Semester in the prescribed application form (as annexed) latest by 1<sup>st</sup> May, 2024 to the Head of the School.
8. Considering the requests of the students, the final list of courses being offered for registration will be forwarded to Examination Section by 6<sup>th</sup> May, 2024.
9. Registration for the Summer Semester will be done between 8-9<sup>th</sup> May, 2024. Students are required to ensure submission of relevant Academic Fee and Mess Fee for the Summer Semester at the time of registration.
10. Registration fee for Summer Semester shall be Rs. 3000/- per course
