- 5. If it is found subsequently that the official is not entitled for the said in Situ promotion, the In-Situ promotion granted herein above shall be withdrawn and monetary benefit so drawn will be recovered without any notice.
- 6. That the arrears on account of In-Situ promotion shall be drawn in favour of the official by the concerned DDO (Finance officer) in terms of the SoPs of the SMVDU.
