5. If it is found subsequently that the official is not entitled for the said in Situ promotion, the In-Situ promotion granted herein above shall be withdrawn and monetary benefit so drawn will be recovered without any notice.
6. That the arrears on account of In-Situ promotion shall be drawn in favour of the official by the concerned DDO (Finance officer) in terms of the SoPs of the SMVDU.
7. The above shall confer no right/claim to any of the vacant post corresponding to the Pay band and Grade pay on which the employee has been placed nor shall confer any claim for eligibility to the next higher post.
