## ORDER

In reference to order no. SMVDU/Adm/Estt./NT/33<sup>rd</sup> EC/ATR/2024/066-068 dated: 12-01-2024 and as recommended by the screening committee constituted vide Ref No. SMVDU/Adm./Estt./NT/2024/211-214 dated: 15.02.2024 for Three Tier Career Advancement (In-Situ Promotion) Scheme for Non Teaching Staff (Category C) and as approved by the Competent Authority, Sanction is hereby accorded to the placement of Mr. Pankaj Nargotra, Assistant Accounts Officer in next higher Grade Pay (1<sup>st</sup> Step) as mentioned below, after his having completed 08 years of regular Satisfactory Service since 29<sup>th</sup> Sept 2015:

The above shall however be subject to following:

1. That the undertaking/option on the prescribed forms is obtained from the official under rules.
2. That no criminal/disciplinary/under suspension proceedings are pending against the official.
3. That scrutiny/verification is made with original service records in respect of pay/grade/pay fixation etc. in accordance with SMVDU rules.
4. That the work and conduct of official has remained satisfactory.
5. If it is found subsequently that the official is not entitled for the said in Situ promotion, the In-Situ promotion granted herein above shall be withdrawn and monetary benefit so drawn will be recovered without any notice.
6. That the arrears on account of In-Situ promotion shall be drawn in favour of the official by the concerned DDO (Finance Officer) in terms of the SoPs of the SMVDU.
7. The above shall confer no right/claim to any of the vacant post corresponding to the Pay band and Grade pay on which the employee has been placed nor shall confer any claim for eligibility to the next higher post.
8. That there is no writ petition(s) filed by him/her is pending for consideration before any Court of Law.
