- 3. That scrutiny/verification is made with original service records in respect of pay/grade/pay fixation etc. in accordance with SMVDU rules.
- 4. The work and conduct of the official shall be regularly monitored by their controlling officer.
- 5. If it is found subsequently that the official is not entitled for the said in Situ promotion on account of any intermittent benefit, the In-Situ promotion granted herein above shall be withdrawn and monetary benefit so drawn will be recovered without any notice.
