- The Faculty members of SMVD University having impact factor (JCR) more than 1 of the publication in the reputed journals such as SCI/SCI-E/SSCI/ABDC shall be provided Certificate of Appreciation and one Memento and Shawl for Research papers in each calendar year w.e.f. January, 2023.
- The Faculty members of SMVD University having cumulative impact factor (JCR) of the publications of more than 15, 10 and 5 in each calendar year (w.e.f. January, 2023) shall be facilitated by way of Certificate(s) of Appreciation (Gold, Silver and Bronze) respectively alongwith one Memento and Shawl.

- iii. The Faculty members of SMVD University having more than 2.5% of the cumulative citations of the University in each calendar year in the Scopus database shall also be provided Certificate of Appreciation and one Memento and Shawl in each calendar year (w.e.f. January, 2023).
- iv. The faculty members who are actively involved in various research projects having minimum average funding of Five Lakhs INR per annum funded by the different Government/Private agencies shall be provided Certificate of Appreciation and one Memento and Shawl in each calendar year (w.e.f. January, 2023).
- v. The faculty members actively involved in various consultancies having minimum consultancy fund of Ten Lakhs INR per annum funded by the different Government/Private agencies shall also be provided Certificate of Appreciation and one Memento and Shawl in each calendar year (w.e.f. January, 2023).
