Remarks	The school members agreed and has no objection in organizing of One-Day Webina on "Smart IOT Device: Future and Challenges" and recommend to process a SMVDU rules.

Remarks	It was discussed and decided unanimously that for all courses to be offered in a semester the faculty allocation from SoECE/SoEE shall be given preference. In case of non-availability of departmental/internal faculty the services of other department will be taken in care.
Agenda 6	Engagement of Experts/ Consultant to prepare the course booklet etc. as per NAAC/NBA and others requirements
Remarks	The AAC members agreed and recommended to engage the consultant for the agenda item above.
Agenda 7	Regarding change in PhD. Regulations
Remarks	It has been observed that PhD ordinances are changed without consulting departments
	but in Academic Counseling meetings. The new rules as modified are implemented retrospectively. When these rules are implemented retrospectively, no exit window is provided by the university to the concerned students. It is not fair either in the eyes of the regulatory body or law. There are many rulings by the court where retrospective application of rules are prohibited. Therefore, it is suggested that rules should be not implemented retrospectively. A PhD student should be supervised as per the PhD ordinance existing at the time of his/her admission. The changed rules should be implemented on the new admission only. The university follows this policy for undergraduate/post graduate students. Same strategy should be followed for PhD students also.

Remarks	It has been observed that self-appraisal as filled by the faculty members is incomplete in the sense that: it does not include so many other activities by the faculty members. A suitable weightage should be provided to other papers also. The new education policy emphasizes on skill development and that should be reflected in self-appraisal also.
