Those Students who fail to register by 27th January, 2025; their name will be struck off from the rolls of the University. The hard copy of Registration Form, duly signed shall be submitted to the concerned Head of School for records.

The Heads of School shall maintain a record of all the students who have registered and have submitted hard copy of Registration Form along with fee payment receipt & details of those students who have not completed their registration process. The Heads of schools shall send due reminders to the students of their School who do not complete the registration process in time. *All Heads of Schools are requested to continuously monitor E-samarth Portal for real time semester registration status*.

The list of registered students (program wise, class wise, course wise & pending dues) shall be sent by the Heads of the school to Academic Affairs Wing for records by or before 7th Feb,2025.
