Subject: Appointment of CI and Co-CIs regarding the Institutional Consultancy Assignment for Construction of Covered Holding Area at Adhkuwari, Katra, J&K (UT).

With reference to the proposal from Ar. Abhiney Gupta, Assistant Professor & Head, SoALD; letter of appointment vide No.CO/Proj./116/2451-2456, dated 04.03.2024 from Dy. Chief Executive Officer, SMVD Shrine Board, Katra and as approved by the Competent Authority; sanction is hereby accorded to undertake the Institutional Consultancy Assignment for providing Comprehensive Architectural/ Structural Consultancy Services w.r.t. Project entitled "Construction of Covered Holding Area at Adhkuwari, Katra, J&K (UT)".

Ar. Abhimanyu Sharma, Asstt. Professor, SoALD is hereby appointed as Consultant In-charge (CI) and other team members comprising of Ar. Aditya Kumar Singh, Assoc. Prof.; Ar. Abhiney Gupta, Asstt. Prof.; Ar. Navin Gupta, Asstt. Prof. & Ar. Vishal Bhatti, STA, SoALD as Co-consultant Incharge (Co-CIs) for the said consultancy. The said consultancy shall henceforth be referred as 'CP/24/77'.

The estimated cost of the consultancy project is Rs.1.51 Crore. The Consultancy fee is 2% of the project cost excluding GST. The University share will be 50% of total charges i.e. Rs.1,51,000/-. However, the consultancy fee paid to the individual consultant shall be liable for deduction of TDS at source, as per rules. The breakup of the consultancy charges is as under:-
