Sub: Minimum Eligibility for Admission to UG Programs offered by SMVDU during AY 2025-26.

With reference to the recommendations of Heads of Schools and Central Admission Committee constituted for Academic Year 2025-26 and as approved by the Competent Authority, the minimum eligibility criteria for admission to UG programs offered by SMVDU during AY 2025-26 is notified and detailed as under for the information of all concerned :

Biotechnology	Candidate should have passed Senior Secondary School Leaving Certificate or Higher Secondary (12 th Grade) Certificate obtained after successful completion of Grade 12 or equivalent stage of education corresponding to Level-4 with Biology or any allied subject as one of the subject's from a recognized board. Candidates appearing in 12 th class examination are also eligible to apply, however they shall be required to produce the result before 15.09.2025. And Admission shall be done on the basis of merit in CUET (UG)-2025.

Please Note:

1. For the candidates* (except SC/ST/ PwD categories), the minimum eligibility is 50% marks aggregate or equivalent grade in the qualifying examination as per the Program-Specific Eligibility.
2. In case of SC/ST/ PwD the minimum eligibility is 45% marks in aggregate or equivalent grade in the qualifying examination as per the Program-Specific Eligibility.
3. * Reservation in admissions shall be as per policy of the Government of UT of J&K as adopted and notified by the University.
4. ** University may conduct its own entrance test for admission to the leftover seats (except S. No. 8 and 10) and all seats (S. No. 8 & 10) or may admit students on the basis of merit in qualifying examination in some or all the above degree programs details of which shall be separately released in line with policy adopted for the PG programs.
5. In case of allied subject equivalence, the decision of the University shall be final and binding wherever applicable.
