Agenda Point 1 - The syllabus of B. Tech. Civil Engineering as per NEP 2020 for first to eighth semester including the syllabus of B.Tech. Honors (Environmental Engineering and Structural Engineering) and Minor Specialization (in Civil Engineering)

Discussion – During BoS meeting, the detailed exploration of the B. Tech. Civil Engineering curriculum in accordance with the directives laid out in the National Education Policy (NEP) 2020. This involved a comprehensive analysis of both core and elective courses offered within the program. One notable recommendation put forth by the expert was to enhance the importance placed on core courses within the curriculum. This suggestion stemmed from a recognition of the fundamental role that core subjects play in providing students with a strong foundational understanding of civil engineering principles and practices. The detailed discussion revolved around the syllabus of B.Tech. Civil Engineering in accordance with the NEP 2020, specifically focusing on the first to eighth semesters The expert Prof. Rizwan Ahmad Khan suggested to maintain minimum eligibility criteria for award of B.Tech. Honors (Environmental Engineering and Structural Engineering) degree.

Decision – The BoS approved course structure for B.Tech. Civil Engineering as per NEP 2020 for year 2024 -25 onwards as placed as Annexure A.
