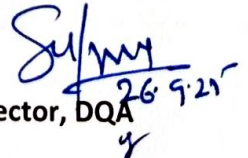
- Organizing of Workshop on Micro Climatology Assessment with effect from 25-09-2025 to 27-09-2025 at SMVD University.
