- 4. The quotations should be submitted in sealed cover, addressed to the Head of School of ECE, super-scribing the NIQ issue number & date and due date & time failing which the quotation is liable to be rejected.
- 5. Price quoted for the material shall be final and valid for 3 months.
- 6. Quotation without the authorization from the Company will not be accepted.
