In supersession of the previous notification issued vide no: SMVDU/AA/18/845 dated: 03-11-2018, regarding the above captioned subject and as approved by the Competent Authority, the following revised guidelines are notified for issuance of Duplicate Grade sheet/Transcript/Provisional Passing Certificate due to loss/damage:

- 1) Student seeking issuance of Duplicate Grade sheet / Transcript / Provisional Passing Certificate due to loss / damage shall make such request in a prescribed format (as per Annexure 'A') alongwith the following documents and applicable fee:
 - An affidavit from 1st class magistrate on ₹ 100/- stamp paper in original in a prescribed format (As per Annexure 'B').
 - ii. Original copy of FIR/Missing report from Police Station of the area where the certificate is lost.
 - iii. Cutting of advertisement in original in the prescribed format (As per Annexure 'C'), published in newspaper (Local to the place of residence) informing that the applicant is applying for issuance of duplicate Grade sheet / Transcript / Provisional Passing Certificate and objection (if any) to be communicated to Registrar SMVDU, Katra within a period of 01 (One) month.
 - iv. Photocopy of the missing Grade sheet / Transcript / Provisional Passing Certificate, if available.
 - Application Fee:
